**Pascagoula Notes- Table 1**

1. Vessel assistance includes only one docking, undocking, or shifting, as stated in the applicable Call Out Order from a Dispatcher for the Port of Pascagoula.
2. Minimum Hire Period Per Tug: Docking and Shifting – 2-Hour Minimum, Undocking – 1-Hour Minimum. Any part of an hour worked will constitute a whole hour.
3. All rates quoted herein apply to each individual tug.
4. Charter Hire: For docking operations, charter hire will commence when the Tug is located at the mouth of Bayou Casotte, and for undocking operations and shifts, charter hire will commence when the first line from the Tug is connected to the vessel. For all other operations, including ship assist at JCPA Terminals on the Pascagoula River, all charter hire shall be payable from departure until return of the Tugs to Signet's dock or terminal facility.
5. For the entire period between delivery and redelivery of the Tug, and during any periods following redelivery when Owners are obligated to repair, restore, or clean off the Tug, Owners shall pay Signet compensation for the Tug at the rates specified in this Tariff.
6. All towed Vessels must provide their own hawsers.
7. The rates set forth in this Table 1 include free time of up to one half (1/2) hour. Any time for each Tug in excess of one half (1/2) hour shall be charged at the applicable rate per Tug per hour. In addition, if the Tow is delayed for any reason not attributable to Signet after dispatched for the work, all such delays shall be charged in accordance with the Delay Fee.
8. GRT Fees: Vessels with 0 to 50,000 GRT will be charged \$37.00 per each 1,000 tons or fraction thereof (rounded up). Any Vessel over 50,001 GRT will be charged \$48.00 per each 1,000 tons or fraction thereof (rounded up).
9. Fuel Surcharge: The Base rate for fuel used to calculate tariff rates is \$2.00 per gallon. A fuel surcharge will be charged in accordance with Tariff General T's and C's when fuel costs exceed this amount. All invoice amounts are calculated subject to prevailing fuel charges at 1% for every \$0.05 per gallon increase above the \$ 2.00 benchmark.
10. Overtime: An additional 35% charge shall be in effect (i) on weekdays between the hours of 1701 and 0759; (ii) Saturdays and Sundays; and (iii) on Signet holidays, (each a "Holiday", and (i)-(iii) collectively "Overtime"). If a Holiday falls on Saturday, the rate will be in effect on the Friday prior to the Holiday. If a Holiday falls on Sunday, the rate will be in effect on the Monday following the Holiday. All in accordance with Tariff General T's and C's.
11. For the avoidance of doubt, the rates in this Table 1 do not apply to towage assistance to rigs.

13. **Pascagoula Notes- Table 3**

1. Vessel assistance includes only one docking, undocking, or shifting, as stated in the applicable Call Out Order from a Dispatcher.
2. Charges in Table 3 are solely for the use of moorings provided at the fleeting facility.
3. Barge fleeting commences at 0001 hours, and any partial day of fleeting a barge will constitute a full day.
4. All rates quoted herein apply to each individual barge.
5. For the entire period between delivery and redelivery of the Barge, Charterer shall be responsible for repair, restore, or clean off any damage to cordage and other equipment as per Tariff T's and C's.
6. Barges shall be moored to the fleeting buoys with the 1" Amsteel Blue or equivalent attached to each end of the barge. All barges that are placed outside the buoy barge shall be secured fore and aft with lines that are equivalent to the strength of a 1" Amsteel Blue. Any tug that moors a barge in the fleet shall be responsible for the security of that barge.
7. The Fleet Office maintains a 24-hour notice telephone and radio watch for fleet business. Whenever possible, Tows bound for Pascagoula should give 24-hour notice to Signet with an estimated time of arrival, number of barges, and description of barges (including any apparent damage and commodity). Arriving and departing tows shall provide a 4-hour notification to the Fleet Office or Tug. Prior to arrival or departure, the number of barges arriving and/or departing with their corresponding barge numbers must be furnished.
8. No watchman service is maintained at the fleeting facility.
9. In the event of warnings or threat of severe weather, Owners are responsible for the timely removal of their vessels and/or barges to protected areas or such other locations as they may deem advisable. When faced with impending named storms, Tows should contact the Fleet Office prior to leaving safe harbor for Pascagoula. In the event that the barge owner has not removed his barges from the fleeting area, prior to the storm, the Jackson County Port Authority and the U.S. Coast Guard may direct the barges be moved to another location, which movement shall be for the account of Owners. Owners are responsible to provide a complete mooring plan for the Port and the USCG for any barge remaining in Port after being directed to move.
10. A Signet Tug is assigned fleet duty and shall check the security of all fleeted barges routinely on a daily basis. For security reasons, the shifting of barges to and from local terminals is the responsibility of the Tug. All barges that arrive or depart the fleet in tow of vessels other than the Fleet tug will be charged an In/Out Charge as set forth above in this Table 3.
11. In the event that winds in the barge fleeting area exceed 25 knots sustained, Signet shall deploy an assist tug to stand by and assist the fleeted barges as reasonably necessary, always at the Master's discretion, and always within the safe and natural capacities and capabilities of the assist tug, her Master, and her crew.
12. Payment terms are net thirty (30) days from the invoice date in accordance with Tariff General T's and C's. Where an invoice is disputed, the Owners shall notify Signet before the due date and pay the undisputed portion of the invoice within the required time.

13. Tow Master Fee plus travel and fees per occurrence will be billed when a harbor pilot, docking pilot or outside tow master are not provided and are deemed necessary by local, state and federal authorities. Owner shall pre- approve before use. (quotation upon request)
14. Cancellation: If Owners cancel requested Services in fewer than 12 hours prior to the commencement of work, in accordance with Tariff General T's and C's a cancellation fee of 4 hours per Tug at the applicable rate will be charged. If Owners cancel or postpone requested Services after the Tugs have departed the dock to commence the Services for work under this Table 4 tariff, then Owners will owe a cancellation fee of the minimum firm charter period under the Tariff plus any other expenses for Owners' account agreed upon. All in accordance with Tariff General T's and C's.
