Ingleside / Corpus Christi Notes- Table 1

1. Notice required for ordering Tugs - A request for Tug services shall be submitted at least 3 hours in advance in writing.
2. Vessel assistance includes one docking, undocking, or shifting.
3. All rates quoted herein apply to each individual Tug.
4. Billable time starts when the tug leaves its duty station ("delivery") and ends when it returns to its duty station ("redelivery"). Any part of an hour worked will constitute a whole hour.
5. For the entire period between delivery and redelivery of the Tug, and during any period following redelivery when Owners are obligated to repair, restore or clean off the Tug, Owners shall pay Signet for the use of the Tug at the rates specified in this Port Specific Rate Table.
6. All towed Vessels must provide their own hawsers.
7. Standby rate will apply when a Tug is ordered and engaged to dock, undock or shift a Vessel and the Tug is standing by the Vessel, ready to perform the Services. The Owners will be billed the hourly standby rate along with any overtime or other surcharges when applicable.
8. Escort type services requested by the Owners, agent, pilots, harbor master's office or any other waterway authority will be billed at hourly rates as described above.
9. Gross Registered Tonnage Fee: Vessels with a 0 to 50,000 GRT will be charged \$18.00 per thousand tons or fraction thereof (rounded up). Vessels with a 50,001 to 90,000 GRT will be charged \$28.00 per thousand tons or fraction thereof (rounded up). Any Vessels over 90,001 GRT will be charged \$38.00 per thousand tons or fraction thereof (rounded up).
10. Fuel Surcharge: The Base Rate for fuel is \$2.00 per gallon. A fuel surcharge will be applied in accordance with the General Terms and Conditions of Tariff when fuel costs exceed this amount. All invoiced amounts are calculated subject to prevailing fuel charges at 1% for every \$0.05 per gallon increase above the \$2.00 per gallon Base Rate.
11. Overtime: An additional 35% fee will be charged (i) on weekdays between the hours of 1701 and 0759, (ii) on Saturdays and Sundays, and (iii) on Signet recognized holidays. If a holiday falls on Saturday, the overtime fee will be in effect on the Friday prior to the holiday. If a holiday falls on Sunday, the overtime fee will be in effect on the Monday following the holiday. See General Terms and Conditions of Tariff.
12. Emergency Escorting and Towing: A 35% additional charge will be added to all rates in this Table 1 when a Tug is engaged in emergency towing and assisting or deadship towing and assisting. This charge is in addition to any overtime or other surcharges when applicable.
13. Cancellation: If Owners cancel or postpone requested Services after the Tug(s) have left their duty station a four-hour per tug minimum charge at the applicable rate will be applied.
14. Payment terms are net thirty (30) days from the invoice date (unless otherwise mutually agreed in advance in writing). Where an invoice is disputed, the Owners shall notify Signet before the due date and pay the undisputed portion of the invoice within the required time.

Cancellation: If Owners cancel or postpone requested Services after the Tug(s) have left their duty station a four-hour per tug minimum charge at the applicable rate will be applied. 14. Payment terms are net thirty (30) days from the invoice date. Where an invoice is disputed, the Owners shall notify Signet before the due date and pay the undisputed portion of the invoice within the required time.
